## Voter Services Update

The mid-term elections are over, but your Voter Services Committee has stayed very active.

At the invitation of Estelle Norwood-Evans, Barbara Grosh spoke to her Political Science classes at Nazareth College on the topic of voting rights. We also continued to expand our college campus initiative with Katherine Smith responding to a request from the University of Rochester to participate in their Student Activism Expo. Our Education Study Group, under the direction of Beth Feldman, also extended its reach to East High, with Mary Olinger and Lois Winterkorn presenting our PowerPoint presentation on the history and importance of our vote and registering eligible students for their all-important first vote in the 2016 elections.

The new year promises to be very busy as we continue to focus not only on voter registration, but also voter participation. Prominent on our agenda is our continued co-sponsorship with The Interfaith Alliance of Rochester (TIAR) in the Voter Alliance of Rochester initiative. Active only in Presidential election years since its inception in 2004, The Voter Alliance works with many faith and community groups, encouraging voter registration and participation, with a focus on areas in the City with low voter participation connected to high rates of poverty.

Our student initiatives also appear to be going strong with a new invitation to participate in the RIT Spring 2016 Community Service Fair. Plans are underway for spring semester bookings at the city high schools for the Education Study Group.

The one common thread for all of these activities is our need for volunteers. We need YOU!!! ## LWV Collaborates With Students at MCC

Georgia DeGregorio, Ann Carmody and Gail Wilder are working with the Monroe Community College (MCC) standing committee, **Rock the Vote**. We have registered new voters at summer orientation sessions and at the Constitution Day event held in September. One or more of us attend their regular meetings, and we offer support from the League and ideas for possible programs.

They have been offering pizza events on the nights of the national political debates and collecting a core group to offer more programs on campus. In the spring semester they are interested in an event centered on gun control, possibly including a discussion with James Shepard, Rochester's retired Chief of Police and new County Legislator.

We have provided them with contact information for the Board of Elections so they can pursue bringing voting machines to campus for demonstrations. At each event we provide voter registration forms and offer to take the completed forms to the Board of Elections. We have also provided *Who Represents You*, the 2015 Voter Guide, organ donation information and New Voter brochures.

Their Student Government President meets monthly with the other student government presidents of the local colleges and universities in our area, and he will propose the idea of working together to share ideas and political events.

In addition to our work at MCC, Voter Services Chair Gin Busack has spearheaded a successful voter registration drive at The College at Brockport, and we expect to return next semester to continue that work.

We are continuing to make connections with the area colleges and universities to determine how we can facilitate voter registration and share the expertise of LWV-RMA.

## Sunshine Corner

### MONROE COUNTY LEGISLATURE DECEMBER 8, 2015 OBSERVED BY ELAINE SCHMIDT

Dr. Dan Ross was one of eight speakers who addressed the Legislature. Dr. Ross expressed concern that Monroe County Child Protective Services would need increased staff to meet the County's responsibilities to county citizens.



A speaker from the advocacy group *Mothers Out Front* proposed that Emergency Response expenses associated with accidents including oil tankers in Monroe County should be paid by the private companies involved.

The County Budget was presented followed by several amendments by the minority party. The amendments included proposals for \$50,000 help fund a shelter for the homeless, an increase in child care monies and money to reinstate Sunday hours at the Central Library. All the amendments were defeated along party lines.

### WEBSTER TOWN BOARD NOVEMBER 5, 2105 OBSERVED BY LOIS WINTERKORN

The meeting was attended by 10 non-board citizens.

A public hearing was held to consider adoption of a budget with a property tax levy in excess of the limit established by General Municipal Law Sec 3-C. The tax cap is \$250,000; anticipated health care costs for 2016, however, are \$400,000.

## Money in Politics

The new federal budget bill passed by Congress in December and signed by the President contains two provisions regarding money in politics.

One provision blocks the IRS from creating rules to curb growing abuse of tax law used by "social welfare" 501 (c) 3 organizations from raising and spending money on political campaigns. Donors to these organizations are not required to disclose their contributions.

LWVUS opposes this provision.

The second provision bars the Securities and Exchange Commission (SEC) from finalizing rules requiring corporations to disclose their campaign spending to their investors, thereby ensuring the continuation of the status quo. Currently, no one, including shareholders, can determine how much a corporation is contributing to campaigns.

The LWVUS position states in part "...that the methods of financing political campaigns should ensure the public's right to know..." Our federally elected officials appear not be interested in supporting this.

LWVNY will continue to support state legislation that supports money in campaigns being made public.

On January 13, 2016 Governor Cuomo announced in his State of the State message that Paid Family Leave (PFL) is one of his top priorities for passage this Legislative session. LWV-RMA has been following this issue and plans to hold an informational forum on April 18 at the AAUW House.

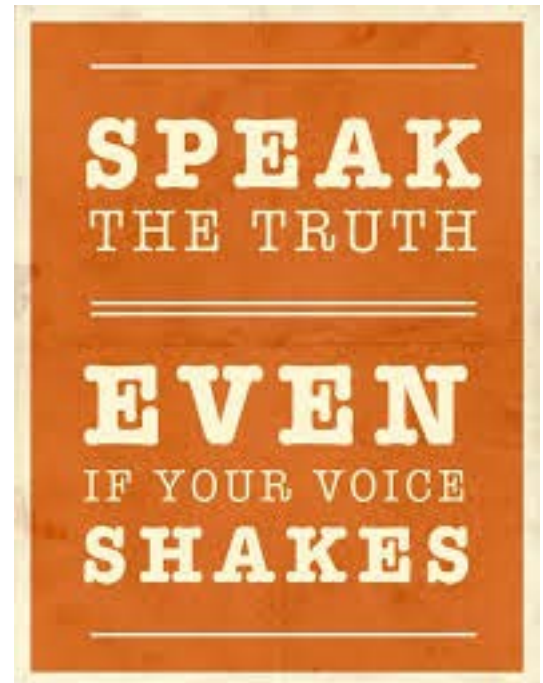
