

2011 TIMETABLE FOR APPROVAL OF REDISTRICTING PLAN UNDER S.1614-B/A.5279-B

(maximum time allotments used)

First redistricting plan submitted to legislature – May 15th, 2011

- No later than May 20th, the plan in the form of legislation must be introduced (5 days)
- No later than June 1st, commission's hearings on plan must be completed
- No later than June 8th, legislation is required to be voted upon (7 days)
- **If approved by the governor the plan becomes law. Otherwise ...**

1. If legislature passes first plan and fails to override governor's veto

- June 13th deadline for sending plan to the governor (5 days), who would veto by June 23rd (10 days)
- July 8th deadline for override (15 days)
- July 23rd, deadline for hearing seeking legislative input after override failure (15 days)
- August 7th deadline for release of **second** plan (15 days)
- August 12th deadline for legislative introduction of **second** plan (5 days)
- September 2nd, deadline for legislative action on **second** plan (21 days)
- **If approved by the governor the plan becomes law. Otherwise ...**

2. If legislature fails to act on first plan

- June 10th deadline for legislature acting on first plan (21 days from May 20th)
- June 25th deadline for hearing seeking legislative input after legislature's failure to act (15 days)
- July 10th deadline for release of **second** plan (15 days)
- July 15th deadline for legislative introduction of **second** plan (5 days)
- August 5th deadline for legislative action on **second** plan (21 days)
- **If approved by the governor the plan become law. Otherwise ...**

1A. If legislature passes *second* plan and fails to override governor's veto

- September 7th deadline for submission to the governor (5 days)
- September 17th deadline for governor to veto (10 days)
- October 2nd deadline for hearing (15 days)
- October 17th deadline for release of **third** plan (15 days)
- October 22nd deadline for introduction of **third** plan (5 days) possibly **with amendments**
- November 12th deadline for action on third plan (21 days)
- November 17th deadline for submission to the governor (5 days)
- November 27th deadline for governor approval (10 days)

1B. If legislature fails to act on *second* plan

- September 17th deadline for hearing (15 days)
- October 2nd deadline for release of **third** plan (15 days)
- October 7th deadline for introduction of **third** plan (5 days) possibly **with amendments**
- October 28th deadline for action on **third** plan (21 days)
- November 2nd, deadline for submission to the governor (5 days)
- November 12th, deadline for governor approval (10 days)

2A. If legislature passes *second* plan and fails to override governor's veto

- August 10th, deadline for sending approved legislation to the governor (5 days)
- August 20th, deadline for governor to veto (10 days)
- September 4th deadline for hearing (15 days)
- September 19th deadline for release of **third** plan (15 days)
- September 24th, deadline for introduction of **third** plan (5 days) possibly **with amendments**
- October 15th, deadline for action on **third** plan (21 days)
- October 20th, deadline for submission to the governor (5 days)
- October 30th deadline for governor to approve (10 days)

2B. If leg fails to act on *second* plan

- August 20th deadline for hearing (15 days)
- September 4th deadline for release of **third** plan (15 days)
- September 9th, deadline for introduction of **third** plan (5 days) possibly **with amendments**
- September 30th deadline for action on **third** plan (21 days)
- October 5th deadline for submission to governor (5 days)
- October 15th deadline for governor to approve (10 days)
